**Terms & conditions**

1. The Agency/ Firm submitting quotation should have valid PAN Card & GST Registrations (if applicable). Agencies/ Firms are required to submit proposals in 2 covers. The first cover shall contain PAN Card and GST Registration Certificate (if applicable). The second cover shall contain the Financial Quote/ Quotation as given at Annex-1(A, B, C, D, E, F, G & H & I). The first cover shall be opened at first and agencies who have submitted PAN Card and GST registration certificate (if applicable), shall be eligible for opening of the second cover i.e. the cover containing the Financial Quote.

3. For each category, agency shall be empaneled at the lowest quoted rate basis. More than one agency may be empaneled at the lowest rate for each category and maximum three (3) agencies shall be empaneled at the lowest quoted rate basis. IAHE shall hire the vehicles as per requirement of IAHE from time to time on roster basis. Further, for **Annexure-1 (I):** Providing A.C Car on monthly basis; only one agency (who submit lowest quoted rates) shall be empaneled.

4. Both the covers should be enclosed in a third cover with “Quotation for Empanelment of Agencies to provide AC Vehicles (Bus, Tempo Travelers, Car etc.) to Indian Academy of Highway Engineers (IAHE), Noida as per requirement basis” to IAHE’s NIQ bearing no. IAHE/Admin./10/Empanelment – Vehicle /2021-22 dated 05.07.2022”.

5. The Vehicles shall be hired by IAHE from the empanelled agency from time to time as per the requirement during the period of empanelment as per agreed terms & conditions including rates.

6. The empanelment of the agency shall be initially for One Year, which is further extendable for two more years, on yearly basis based on satisfactory provision of services.

7. The Vehicles shall be in Excellent Condition.

8. The Vehicles supplied should be commercial vehicles registered with Transport Authority in Noida/Delhi/ NCR.

9. The Vehicle supplied shall have valid Permit to ply in the jurisdiction for which it may be hired.

10. The mileage for use of vehicles starts from assigned place. (IAHE campus or the address given for reporting.

11. Driver of Vehicles should be well experienced and should have valid driving license and should be acquainted with travel routes, properly dressed and well behaved. Driver should not leave vehicle without the permission of the IAHE representative. Driver shall always maintain a Mobile Phone in working condition at the cost of the firm during entire period of service and should maintain proper etiquette/ Protocol.

12. Driver should keep Registration Certificate, Pollution Certificate, comprehensive Insurance Certificate and any other such documents required as per Government rules in force with him always for checking by authorities.

13. Proper record of time/mileage in respect of usage of vehicle shall be maintained.



14. The empaneled agency should give two or more Mobile Telephone numbers for requesting service and should always be responsive.
15. IAHE shall not be responsible for damages of any kind for any mishap /accident etc., caused to any Vehicle, Driver/Third Party or for challans for traffic rule violations while on IAHE Duty. All liabilities legal/ monetary shall be borne by the firm.
16. IAHE Reserves the right to cancel the empanelment at any time without assigning any reasons. The agency shall not be entitled to any compensation on account of such cancellations. Decision of IAHE shall be final in this regard.
17. IAHE reserves the right to obtain supply from other sources.
18. **IAHE may hire vehicles at the lowest rate from other agencies, if services provided by empaneled agencies are not found satisfactorily**, to suit the requirements/ convenience of IAHE. In Case of deficient service/discontinuation of service, the Empanelment can be cancelled at any time and the firm/Agency can be debarred for minimum of 2 years from any future bidding in IAHE.
19. All charges towards maintenance/servicing /salary and other expenses of Driver/ fuel or other incidental expenses shall be borne by the agency. In case of breakdown of vehicle, the agency will provide replacement immediately.
20. The payment shall be made by Cheque or NEFT/RTGS within 7 days of completion of journey and submission of bills. Details of Bank Account (Name of the account holder, Nature of account, Account number, Bank name /Branch) shall be specified in the quotation.
21. IAHE reserves the right to cancel the NIQ even after receipt of quotations without assigning any reason.
22. In case service is not provide on a particular day as per requisition, a penalty of Rs. 1500/- per day for Bus/Tempo Traveller and Rs. 500/- per day for Car/SUV shall be levied and recovered from bill. Additional penalty can also be levied for violations of terms and conditions.
23.
