Terms & Conditions

- The agency submitting quotation should have valid PAN and GST registration. Agencies are required to submit proposals in 2 covers. The First Cover shall contain a copy of PAN Card, GST Registration Certificate and Security deposit of Rs. 5,000/- in the form of Demand Draft / Bankers Cheque of a scheduled bank drawn in favour of Indian Academy of Highway Engineers payable at Noida. The second cover shall contain the Financial Quote / Quotation as given at Annex-1. The First cover shall be opened at first and agencies who have submitted PAN Card, GST Registration certificate & Security deposit shall be eligible for opening of the second cover i.e. the cover containing the Financial Quote. The work shall be awarded to the firm submitting the lowest Financial Quote (Grand Total Price). Both the covers should be enclosed in a third cover with "Quotation for Supply of Cement putty & painting material etc. to Indian Academy of Highway Engineers (IAHE)" in response to IAHE's NIQ bearing No. IAHE/Admin/14 /BW-R&P/2021-22 dated 27.10.2021.
- Prospective bidders are encouraged to visit the site for proper understanding the location for supply 2. of material etc. before submitting the quotation.
- All the items shall be of approved brand/make and have appropriate Guranatee/Warantee given by the manufacturer. Quantities mentioned in the Faninacial quote are estimated quantities and may vary at the time of supply order issued. 

- 5. The supply of all items/ material should be completed in all respect within seven (07) days after issue of supply order.
- 6. Security Deposit and full payment shall be made on successful supply of all items/material in all respect within seven (07 days).
- 7. Rates for all the items (mentioned in Annexure-I of NIQ) must be quoted by the agency / firm. If any agency/firm fails to quote any items, his quotation shall be considered as incomplete and shall be rejected. Evaluation will be done on the basis of Grand total price. Rates must be quoted as per units mentioned in quantities column at Annexure-I.
