Sir,

Please refer to IAHE letter of even no. dated 5th April, 2023 vide which M/s Enkay Enterprises was declared as 'Non-Performer' due to non-performance of its obligations under the contract agreement for aforesaid project (copy enclosed).

- 2. Now, Chief Materials Engineer, Central Materials Laboratory (CML), Ministry of Works and Transport, Kampala, Uganda vide his letter no.CML/Equipment/001/23 dated 23rd Sept, 2023 (received vide email on 26th Sept, 2023 @ 7.39 PM) addressed to M/s Enkay Enterprises with copy to Joint Director, IAHE has confirmed that A team of technical representatives from M/s Enkay Enterprises arrived at Uganda on 15th Sept, 2023 and completed the installation during 16-23 Sept, 2023. It is also intimated that M/s Enkay Enterprises has conducted installation, demonstration, commissioning and training for equipment supplied under the captioned contract in accordance with the terms of the agreement. The installation has been completed on 23rd Sept, 2023 after delivery of equipment at CML, Kampala on 16th Aug, 2022, viz. over 13 months period.
- 3. Keeping the fulfillment of the obligations by M/s Enkay Enterprises though after delays and report on satisfactory installation, demonstration, commissioning and operational training by the CML, Kampala, IAHE hereby withdraw 'Non-Performer' status imposed on the agency with immediate effect.
 - 4. This issues with the approval of competent authority.

Subject: Establishment of Regional Materials Testing Laboratory in Uganda under IAFS-II – Installation and commissioning of all the equipment at final destination CML, Kampala, Uganda – Declaration as 'NON-PERFORMER' agency regarding.

Sir,

Consequent upon the notice served under the 'Clause 2.26 Termination for Default' vide email dated 3rd March, 2023, M/s Enkay Enterprises neither submitted comprehensive response nor sent his team of personnel to complete installation, commissioning, acceptance of equipment, organize demonstration and hands-on training at CML, Kampala, Uganda as per the agreement.

- 2. It has been intimated to M/s Enkay Enterprises several times in writing that 4th Extension of Time (EoT) granted had already expired on the 31 Jan, 2023 but no action has been taken for the extension as well as submitting revised timelines and completing the project. The equipment supplied by M/s Enkay Enterprises vide Ref. No.EKE/2021-22/IAHE/Payment dated 16.08.2022 are lying at CML, Kampala, Uganda in the want of the installation, testing, commissioning and hands-on training for their intended utilization and purposes. However, IAHE had already paid a total 90% payment (refer clause GCC 2.20 of SCC) of contract amount on 4th Oct, 2022 and 15 Nov, 2022 against the bills submitted. Since then M/s Enkay Enterprises is neither deputing his team of personnel for installation, testing, training and commissioning the laboratory equipment nor submitting any response.
- 3. The task for installation, commissioning, testing, etc. has not been completed even after several months of the scheduled completion period. As such your firm has been rated as 'NON-PERFORMER'. Further necessary actions in terms of the contract agreement shall be initiated under the Clause 2.25 Penalty clause and Clause 2.26 of GCC and SCC of the agreement including debarment/blacklisting, forfeiting performance security, imposing liquidated damages for delays and not performing the obligations specified under the scope of supply (refer clause 2.4 of GCC and items in the list at page 55 of the agreement).
- 4. M/s Enkay Enterprises is therefore declared as 'NON-PERFORMER' agency in terms of Standard Operating Procedure to debar/penalize/declare the contractor/concessionaire as Non-Performer issued vide F.No.RW/NH-33044/76/2021-S&R(P&B) dated 4th Jan, 2022 and DoE, MoF guidelines issued vide O.M. F-1/20/2018-PPD dated 02.11.2021.
 - 5. This issues with the approval of competent authority.




